Sign Must Be Posted at all Residential Construction Sites

The City of Covina has formally approved the Covina Residential Public Noticing Program. The program is intended to provide communication tools to inquire about and provide verification of building projects taking place in neighborhoods. Public notification signs must be visibly posted and maintained within the front yard by the contractor and/or property owner during construction. The following types of residential improvements are examples of when signage is required:

This sign program became effective on July 1, 2008. The signs will indicate that the project has been reviewed, approved, and will be inspected periodically by the City to verify compliance with State and Municipal Codes.

The signs also provide the contact information for key persons involved in the project to report potential noise disturbances. If initial contact fails to resolve the noise problem, the Building and Safety Section telephone number is also provided to report continuing concerns and request appropriate enforcement.
