To establish, change or terminate refuse service, contact Covina Disposal through their website at <http://athensservices.com> or toll-free telephone number, (888) 336-6100. Covina Disposal is open Monday - Friday, 7 am - 5 pm and Saturdays, 7am - Noon.

### **New Refuse Rates as of July 1, 2013**

*Effective July 1, 2013, City of Covina refuse rates will be adjusted due to inflation. The standard monthly residential barrel service rate will be **\$27.05**. The standard monthly commercial rate (a 3 cubic yard bin serviced once a week) will be **\$152.33***

### **Residential Refuse Service**

Basic residential refuse service consists of three, 90-gallon containers: a black trash container, a blue or gray recycling container and a green container for green waste. All are collected weekly. Currently, this basic residential service is \$27.05 effective July 1, 2013.

Qualifying low-income senior citizens are eligible to apply for 30 gallon refuse service. Please fill out [this application](#) and return it to Environmental Services with supporting documentation either in person at City Hall or via fax to (616) 384-5479.

### **Commercial and Multi-Family Refuse Service**

To establish or change commercial refuse service (including commercial, industrial, and multi-family residential accounts), please contact Covina Disposal directly at (888) 336-6100. Commercial customers may chose from a variety of bin sizes and varying frequency of collection.

### **Residential Refuse (Trash) Collection Schedule**

Residential refuse is collected on a weekly basis. For single family residences, refuse is placed in the black barrel.

### **Residential Recycling**

Curbside recycling for single family residences is now **collected weekly**, on the same day as the black barrel. Recyclable items are placed in the gray or blue barrel. For more information on recycling, [click here](#).

### **Multi-Family Recycling**

Commercial and industrial facilities and multi-family complexes using bins also participate in recycling. Contents from bins (dumpsters) are taken to a Materials Recovery Facility (MRF) where contents are sorted, and recyclables are separated and processed. ### **Green Waste**

Residential green waste (leaves, small branches, grass clippings) is placed in the green barrel. Green waste is collected on a weekly basis. For more information on green waste, [click here](#).

### **Bulky, Large Item Collection**

Customers with commercial or industrial accounts, please contact Athens Services/Covina Disposal for available services and applicable fees.

### **Household Hazardous Waste, Electronic Waste and Universal Waste**

Household hazardous waste is any item to be disposed that is labeled toxic, poisonous, corrosive, flammable, combustible or an irritant. In addition, there are items that are detrimental to the environment or pose health risks if not properly disposed. Electronic Waste (E-Waste) refers to consumer electronic equipment that is no longer wanted. E-waste can include computers, printers, televisions, VCRs, cell phones, fax machines, stereos, and electronic games. Universal wastes are hazardous wastes that are widely produced by households and many different types of businesses. Universal wastes include televisions, computers and other

electronic devices as well as batteries, fluorescent lamps, mercury thermostats, and other mercury containing equipment, among others. Hazardous waste, universal waste and e-waste are NOT to be thrown in the trash; the simplest way to properly dispose of these items is by taking them to a Household Hazardous Waste (HHW) Roundup. ### Used Oil Recycling

It is illegal to dispose of used oil in the trash, on the street, on the ground, in streams, or in flood control channels. Used motor oil is dangerous. Children should not breathe the fumes or get oil on their skin.
