PERMIT REQUIREMENTS AND INFORMATION FOR MOTION PICTURE, VIDEO, AND PHOTOGRAPHY FILMING

1. Permit application **must** be made (5) five business days in advance of filming. Please allow additional time depending on the size and scope of the project. Covina City Hall is open Monday through Thursday, 7:00am to 6:00pm.
2. The permit fee is \$300 per day which includes the business license. Additional fees may apply.
3. An original certificate of insurance for two million dollars with notarized endorsement naming the ***City of Covina/Successor Agency to the Redevelopment Agency*** as additional insured.
4. Police personnel may be required on certain locations and definitely are required when work is done on public property. Estimates of schedule shall be provided and payment for such coverage must be paid in advance of location work. The current hourly rate is **\$85.00** per hour, per employee.
5. A Covina Encroachment permit is required for work performed in the public right-of-way. The City's permitting official will provide information on obtaining the appropriate permits.
6. Approval by Los Angeles County Fire Department is required and an LACO Fire permit with approval of Fire Safety Officer may be needed (permit application included in this packet). Acquiring LACO Fire approval is the responsibility of the applicant.
7. Location work involving traffic stoppage or road closure is prohibited on Citrus Avenue between the hours of 10:00am and 5:00pm. Consideration will be made for location work requiring intermittent traffic and/or pedestrian control.
8. Notification of businesses or residents impacted by location work is required.
9. A plot plan detailing production activity is required.
10. Independent businesses providing support services to production are required to have a separate City business license.

Permittee waives all claims against the City of Covina, its officers, agents and employees, for loss or damage caused by, arising out of, or in any way connected with the exercise of this permit; and permittee agrees to save harmless, indemnify and defend City of Covina, its officers, agents, and employees, from any and all loss, damage or liability which may be suffered or incurred by City of Covina, its officers, agents, and employees caused by, arising out of, or in any way connected with exercise by permittee of the right hereby permitted, except those arising out of the sole negligence of City of Covina.

The City of Covina shall have the privilege of inspecting the premise covered by this permit at any and all times.

The permit shall not be assigned.

The City may terminate this permit at any time if permittee fails to perform any covenant herein contained at the time in the manner herein provided. The City agrees it will not unreasonably exercise this right of termination.

The parties hereto agree that the permittee, its officers, agents, and employees, in the performance of this permit shall act in an independent capacity and not as officers, employees, or agents of the City of Covina.

No alteration or variation of the terms of this permit shall be valid unless made in writing and signed by the parties hereto.

Permittee agrees to comply of the terms and conditions contained in the attached Exhibits(s), which terms and conditions are by this reference made a part thereof.

The permittee hereby agrees to comply with all the rules and regulations of the facility or institution subject to this permit.

Permit must be kept on site at all times.

Permittee agrees to all the terms and conditions of this permit including provisions.
