#### WHAT YOU NEED TO KNOW

This program is intended for low-income senior citizens who receive residential trash service in the City of Covina.

#### To participate in the program, residents must:

- □ be 62 years of age or older;
- □ have a valid California driver's license or identification showing proof of age;
- □ be living in a single family residence in Covina;
- meet low-income requirements set by the U.S. Department of Housing and Urban Development (HUD); and
- □ maintain an account in good standing with Athens Services/Covina Disposal.

### WHAT YOU NEED TO DO

To participate in the Low-Income Senior 30 Gallon Refuse Program, you must:

□ Confirm that your income meets the low-income standards set by HUD for the applicable year (see table on reverse side).

□ Complete and submit an application (on reverse side). Ensure that your application is <u>completely filled out and signed</u>. The Environmental Services Division will gladly assist you in completing this form. For assistance, visit us at the Engineering counter at City Hall (125 E. College Street), or contact us by phone at 384-5480 from 7:00 am to 6:00 pm, Monday through Thursday.

□ Provide proof of age with a <u>copy of a valid California identification card or driver's license</u>.

Provide proof of low-income status by submitting <u>copies of any of the following that apply</u>:

- O Professionally prepared Federal and State Income Tax returns for 2023
- Form SSA-1099 Social Security Benefit Statement
- O Social Security Income (SSI) Forms
- O Interest Income
- O Other (see list of "All Types of Income Received Last Year" on reverse)

Please allow 1 - 3 days for processing. You will be notified when your application is approved and your black trash container will be exchanged for a smaller 30 gallon container. The discounted 30 gallon billing charge will appear on the next quarterly billing statement mailed out by Athens Services/Covina Disposal.
