NOTICE OF PUBLIC HEARING

NOTICE IS HEREBY GIVEN that the Planning Commission of the City of Covina will conduct a **PUBLIC HEARING** in the City Hall Council Chambers, 125 East College Street, Covina, on Tuesday, **August 11, 2026 at 7:00 p.m.**, or as soon as possible thereafter, to consider the following item:

1. **Conditional Use Permit (CUP) 25-002**, a request to establish a 2,113-square-foot fitness facility, Hourglass Lab, within an existing multi-tenant commercial center in the C-3A Commercial zone (Regional or Community Shopping Center) located at 983 W San Bernardino Rd, Covina, CA (APN: 8434-001-017).

In accordance with the California Environmental Quality Act (CEQA), the City of Covina has determined that the proposed project is exempt from further environmental review pursuant to the CEQA Guidelines Section 15301, Class 1, Existing Facilities. The project is exempt from environmental review under CEQA because the project involves the operation and permitting of a use within an existing structure involving negligible or no expansion of the existing or former use.

All interested parties are invited to attend the public hearing and provide public comment. The Council Chambers are open to the public and any person may address the Planning Commission in person. Complete the yellow speaker card and submit it to City staff. Your name will be called when it is your time to speak. The public may view the meeting live on the City's website at www.covinaca.gov.

If you challenge the decision on the proposed actions in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence submitted to the Planning Secretary or the Planning Commission at, or prior to, the public hearing.
